- The female will be accommodated by the Stud's home for approximately 10 days unless location of the female allows for repeated single visits.

Attach the following bitch documents:

- Veterinary certificate of negative Brucellosis, negative aerobic cervical (high vaginal) culture and sensitivity taken with guarded instrument and negative mycoplasma culture; white blood count, lyme western blot - dated no more than 30 days before mating.
- Copies of the following tests: Hip Dysplasia, Thyroid – Hypothyroidism, Von Willebrand's Disease, CERF eye examination, cardiac screening including Cardiomyopathy, OFA tests of Hip Dysplasia, Gastric Torsion (Bloat), Seizure Disorders, Wobblers, *and* Orthopedic Disease “OCD, HOD” and a report of healthy teeth, eyes, ears, skin and bone structure.
- A photocopy of all lab reports.
- CKC or other national or local purebred Dane registration documents.
- CKC or other proof of full registration or the right to breed.
- Recent photos of the female Dane showing the head and body structure and/or a video tape.
- Record of any showing.
- Registration and pedigree certificates
- Ownership document.
- Copies of current vaccination records including rabies, as well as a report from the bitch's vet who has been treating her of had her file and done her vaccinations for at least the past 12 months, indicating any health treatment he has administered and any knowledge of the Dane's health and personality.
- Copies of fertility vaginal smear and/or blood tests to determine most fertile days of the female.

- Other clarifications & Terms:

- 1- The applicant (the bitch's owner) agrees to and shall not, either directly or via an agent thereof, sell any puppies resulting from this breeding to a pet shop, kennel or individual for breeding purpose.
- 2- One puppy born alive or dead constitutes a litter and signifies successful service by the stud. However, if only one pup or no pregnancy results from this mating, a return service will be provided at no extra stud fee to the same bitch within one year, provided all conditions of this contract are again met by the applicant.
- 3- If the female fails to conceive on the return visit indicated by the preceding clause, this contract shall be considered completed and terminated.
- 4- The stud fee shall be approximately the price of one pup, priced at \$1500+, unless otherwise is agreed upon.
- 5- A non-refundable deposit of \$500 must accompany this application.
- 6- The remainder of the stud fee (\$1000 remaining) or a pup of the stud owner's choice, whichever the stud owner prefers, shall be given to the stud owner within 6 weeks after whelping; provided that 3 or more puppies have resulted from this breeding.
- 7- The bitch owner shall within one week of whelping, notify the stud owner of the details of the litter (colours, number of males & females .. etc) and give the stud owner first pick option under the preceding clauses.
- 8- If less than 3 puppies are born, the remainder of the stud fee shall be reduced to \$700 or a pup of the stud owner's choice – whichever the bitch owner selects. If the bitch owner chooses to give the stud owner a pup, it shall be the any pup selected by the stud owner.
- 9- The stud fee shall include the cost of feeding the bitch, but shall exclude the costs of: shipping the female back (the bitch owner has paid to ship the female to the stud owner), any medication or treatment or exam/tests or surgery a vet deemed needed based on a decision solely by the stud owner to refer the bitch to a vet. Such costs must be paid to the stud owner prior to picking up or shipping back the female by/to the applicant.
- 10- The applicant / bitch owner is the sole representative of the Dane, and he/she hereby agrees to hold the stud owner (and his agents, representatives, business and associates or any of his other connections) harmless from any claim or law suit. The bitch owner promises to forever release the stud owner from any claim of negligence or any other claim under civil, municipal, local, criminal or any other channel of action. The applicant accepts the stud owner's reputation, creditability and experience as the sole guarantee to offer the bitch his best care and service with the understanding that unfortunate or unforeseen accidents or developments may occur.
